INTRODUCTION TO PVSC



- Independent, not-for-profit organization
- Created by the *Property Valuation Services Corporation* Act in April 2007
- Municipally funded
- Provide property assessment services as per the Nova Scotia Assessment Act

What we Do & Don't Do

PVSC:

- Delivers an Assessment Roll to all 49 NS municipalities by December 31 each year
- Delivers ~630,000 Assessment Notices to NS property owners each January
- Administers the Seasonal Tourist Business
 Designation Program on behalf of the NS government

PVSC does **NOT**:

- Have the authority to:
 - Set tax rates or collect taxes
 - Create tax policy or provide tax relief
 - Change the eligibility requirements or application deadline for the Seasonal Tourist Business Designation Program

What is a Seasonal Tourist Business?

A restaurant, roofed accommodation, or camping establishment that is <u>closed</u> at least four months in the tax year



WHO IS ELIGIBLE?


Eligible businesses are:

- ✓ Closed for at least four months in the tax year (April 1 March 31)
- ✓ A restaurant, roofed accommodation, or camping establishment *
- ✓ Operated by the assessed property owner or their relative (parent, sibling, child, grandchild or spouse)
- ✓ Managed and at least 50% owned by the property owner or their relative. In the case of a corporation, at least 50% of the voting shares must be held by the property owner or their relative

HOW DO I APPLY?

- 1. Fill out and sign the application form.
- 2. Send the completed form to PVSC by September 1st every year


PVSC does not have the jurisdiction to extend the deadline or accept late applications



HOW DO I APPLY?

- Application forms are mailed to previous participants each July

If your property is designated as a Seasonal Tourist Business, it will be noted on your Property Assessment Notice sent in January



If your application is denied, you will be contacted by PVSC
