Dear Minister Morrow,

On behalf of the Tourism Industry Association of Nova Scotia (TIANS), we are writing in support of the Wine Growers of Nova Scotia (WGNS) regarding the scheduled conclusion of the Emerging Wine Regions Policy (EWRP) program and subsequent need for a new program to support this crucial Industry.

The growth of the wine and agricultural sector has played an important role in the development of the Nova Scotia Tourism Industry over the past two decades. As the sector begins to mature, TIANS believes there is tremendous opportunity to leverage and build on that progress as a draw for visitors. With direct economic impact of the Nova Scotia Wine Industry alone valued at \$245 million, and significant indirect revenues in multiple sectors, there is incredible potential for continued expansion and impact in rural communities.

TIANS respects the process of winding down the existing EWRP, and the need for a solution that will address both the needs of the industry - which is at a critical juncture of development - and adherence to required trade regulations. While the proposed Green Box Solution could drive external capital investment, the loss of existing supports available in the current program would be devastating.

TIANS supports the WGNS suggestion to adopt a hybrid model using best practices from other established wine regions in Canada. The existing frameworks being used could be explored as you develop a Nova Scotia Farm Wine Support Program that, in alignment with the Green Box Solution, supports a competitive and sustainable approach to growth.

Nova Scotia is well situated to become the Wine Capital of Canada, however, getting the EWRP replacement program policy right will be key in stabilizing and advancing the sector, encouraging investment and establishing new operations. Honourable Greg Morrow July 7, 2022 Page 2
